5. Proof of payment of the non-refundable deposit to cover for election expenses.
6. A detailed biographical information relating to the candidate, dully signed by the candidate.
7. An extract of the nomination proceedings of the party organ which approved the final nomination of the candidate signed by the Chairman and Secretary General of the Party accompanied by:
 - (a) Candidate party's application for nomination form;
 - (b) A list of all candidates who were contesting to be nominated by the party;
 - (c) Documents (forms) indicating results of the democratic election for all those who were contesting within the party; and
 - (d) A signed list of all voters who voted for nominated candidates.
